The Sacred Music Concentration prepares students for a career in church music. Students can further their studies with a focus on keyboard skills, conducting, church administration, and hymnody. This degree requires a recital either as a performer or conductor as well as a semester-long practicum of working with an area church or synagogue in music ministry.

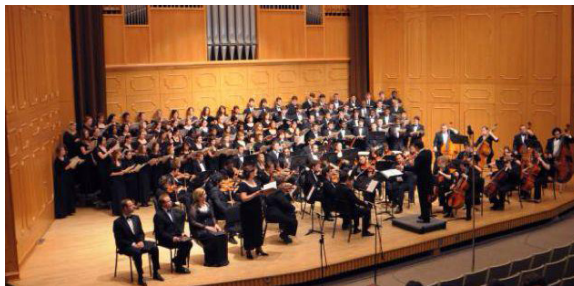
