## REFUND POLICY

A student who officially resigns on or before the last day of regular registration will receive 100 percent credit to his account of all refundable fees. A Student who officialy resigns within the first seven days of class will receive 75 percent credit to his account of all refundable fees. Refundable fees include fees identified on the bill/statement as registration fees, out-of-state fees, laboratory fees and student association fees. A student who resigns on the eighth through the twelfth day of classes will receive a 50% credit to his account of refundable fees identified on the bill/statement as registartion fees, out-of-state fees and laboratory fees. After this date, no refund or credit will be made. Courses dropped with a "W" are not refundable at any time and will not be credited to a student's account. In some cases, the refund policy will result in a reduction of charges and not a "cash" refund. Students receiving Title IV assistance (Federal Financial Aid) will have their financial aid adjusted according to Federal Regulations.

Non-Refundable
Installment Fee – Payment in full is required on scheduled fee payment date. Accounts not paid in full will be assessed an \$85.00 non-refundable Installment Plan Fee and may be subject to a \$45.00 (per billing cycle) Late Payment Charge.
While Northwestern State University does not directly assess any amount for verification of student identity, students taking courses that require protored assignments may incur separate out-of-pocket expenses for proctoring services.
