

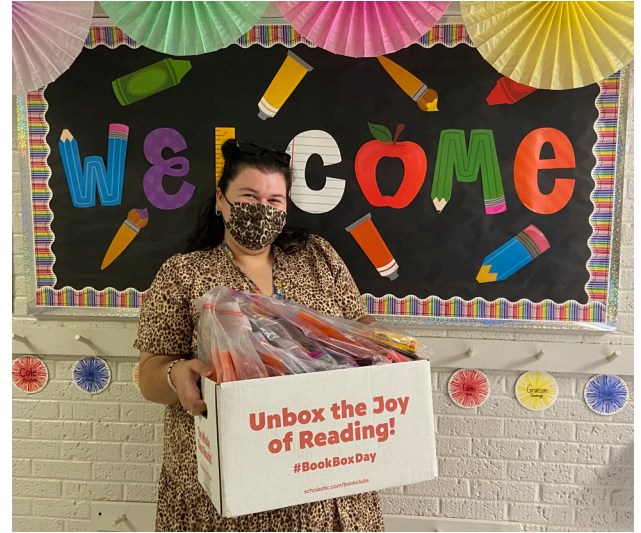


## MASTER OF EDUCATION

### Early Childhood Education (547)

Northwestern State University (NSU) is proud to offer the only M.Ed. in Early Childhood Education program in the state of Louisiana. This advanced program builds on content that certified teachers mastered at the undergraduate level to facilitate their work with young children, their families, and their communities. The degree program is comprised of Education courses and a Practicum experience that address the National Association for the Education of Young Children (NAEYC) standards, and the program involves advanced candidates in strengthening their knowledge, skills, and dispositions relating to working with children from birth to eight years. It is nationally recognized by NAEYC and the Council for the Accreditation of Educator Preparation (CAEP). Through the completion of coursework, students engage in critical and creative thinking and problem solving as they practice differentiating content to meet all students' needs while modeling culturally responsive practices.

The program seeks to prepare teachers of young children for real classrooms in the real world. Students are consistently involved in reviewing and critiquing current peer-reviewed Early Childhood research, analyzing best practices for teaching young children, designing and implementing developmentally appropriate activities for their classrooms, and assessing and documenting their students' achievement. Graduate students also learn to plan and evaluate child-centered emergent curricula and design environments that promote academic, social-emotional, cognitive, and physical growth. They work both independently and cooperatively to gain awareness of programs that focus on children's needs and interests, such as the Project Approach and the Reggio Emilia Approach. Finally, they engage in problem-solving and brainstorming solutions for issues that often arise in today's classrooms while enhancing family engagement and family literacy.

- EDCI 5030    Instructional Improvement and Assessment (Internet Course offered every semester)
- EDUC 5010    Educational Research and Evaluation (Internet Course offered every semester; must have at least 12 hours)
- EDUC 5850    Action Research for School Improvement
- or
- EDUC 5980    Thesis

\* These two courses are taken concurrently.

## Add-on Certification

Students who already hold Elementary certification can add on the Early Childhood grades by accumulating 12 hours of Nursery School coursework. Suggested courses include ECED 5560, ECED 5570, ECED 5580, and RDG 5020, all of which are offered online each summer.
