Meeting was called to order at 3:25pm CST. Roll was called. Chris Brumley acted as Recorder of the minutes. Mr. Woodard outlined the structure of the meeting and budgetary details defined by the proposed FY 2024-25 proposed budget. Lab/Classroom

Development in the amount of \$178,643.15 was approved by the STAT committee for the purchase of rotational equipment that supports classroom and lab computers.

Special Initiatives in the amount of \$187,356.92 was approved by the STAT committee for the purchase of special projects equipment. Contrary to the proposed budget, the committee chose to award the Physical Science Initiative the priority piece of equipment requested and to table the remaining equipment until FY 2025-26.

Operating/Maintenance was approved in the amount of \$482,240.78 for the purpose of educational software and equipment used to maintain and service our lab and classroom environments.

Infrastructure was approved in the amount of \$150,000.00 for upgrades to the Natchitoches network core and Shreveport network. The approval is contingent on Information Technology Services (ITS) securing the additional funds.

Personnel was approved in the amount of \$250,000.00 for employee and student worker salaries.

Discussed were changes to the User Fee Agreement to reflect NSULA restructuring, no longer reporting to the Executive Director of Technology, Innovation, and Economic Development but the Chief Information Officer. Motion passed.

Next meeting tentatively scheduled for 13-November 2024 at 3:30pm CST.

Meeting adjourned at 4:24pm CST.
