¹ Beginning with AY 2022-2023, Fall Semester reporting will have an effective date of April 1st of the current calendar year.² In accordance with Act 472, the Chancellor's report shall include the number of Responsible Employees (i.e., employees) and Confidential Advisors for the institution. ³ In accordance with Act 472, the Chancellor's report shall include the number and percentage of Responsible Employees and Confidential Advisors who have completed annual training. ⁴ Although this section is not required by Act 472, for data collection purposes BOR requests statistics regarding a responsible employees' failure to comply with reporting requirements. ⁵ In accordance with Act 472, the Chancellor's report shall include (1) the number of Formal Complaints of power-based violence received by an institution, (2) the number of Formal Complaints which resulted in a finding that power-based violence violations occurred, (3) the number of Formal Complaints in which the finding of power-based violations resulted in discipline or corrective action, (4) the type of discipline or corrective action taken, and (5) the amount of time it took to resolve each Formal Complaint (see 2nd form).⁶ In accordance with Act 472, the Chancellor's report shall include information about retaliation which include the number of reports of retaliation, and any findings of any investigations or reports of retaliation.

The NSU Chancellor's Data Report reflects the number of Responsible Employees at NSU and the number of people who completed training provided by the Board of Regents as of September 30, 2022. This training was limited to the number of attendees from each Institution. Responsible employees have a requirement to complete the BOR training before the beginning of the 2023-2024 Academic Year.

As a result, 964 of NSU's 980 Responsible Employees have completed the Power Based Violence training, provided by the BOR to date.

The Board of Regent's annual training will be provided to all Northwestern State University Responsible Employees.
