Exchange Agreement between Universidad Libre Colombia and Northwestern State University (EEUU)

In recognition of their common interests in developing bilateral relations and being convinced that cooperation between institutes of higher learning contributes to cultural enrichment, scientific progress, and the consolidation of friendship between Universidad Libre, (hereafter "UNILIBRE"), from Colombia, and Northwestern State University, (hereafter "NSU"), located in Natchitoches, the United States of America, agree to establish the following exchange agreement of Academic Cooperation.

I. General

Article 1.- The institutions agree to exchange experiences and information on questions of pedagogy, methodology, organizations, the contents of instruction and the training of faculty and students, as appropriate.

Article 2.- The institutions agree to exchange research papers, teaching materials, syllabi, curricula, as well as exhibitions and other materials, as appropriate, illustrating the activity and achievements of both institutions.

Article 3.- The institutions agree to exchange faculty members, professional administrators, and students (Undergraduate and Graduate).

Article 4.- The institutions agree to help the professors of both parties to carry out joint research projects.

Article 5.- The institutions agree to collaborate in educational and cultural programs, including publishing activities of mutual interest and shared access to information networks.

II. Exchange of Faculty Members

Article 6.- Both institutions may exchange faculty members as needed and according to their possibilities.

Article 7.- The exchange faculty member shall participate in teaching, delivering lectures or giving special programs such as workshops for people of the receiving country.

Article 8.- The host institution will be responsible for transportation from the nearest airport approved by the host institution to the institution's home campus and back. Proper accommodation and payment will be negotiated at each event.



III. Exchange of Students

Article 9.- Both institutions can exchange students: with a maximum of 2 students per academic year, the equivalent of two semesters of exemption from tuition and fees for two semesters per academic year. Room, meal plan, books, and insurance will be the responsibility of the visiting student. The number of exchange students may increase per semester upon prior

agreement from both institutions. Both Parties agree as an objective to have a reciprocal balance in the exchange for the duration of the agreement.

Article 10.- The exchange of students shall be for (1) study in degree programs (undergraduate and graduate) and (2) participation in research programs, cultural activities, language learning, etc.

Article 11.- Exchange students are subject to the Student Code of Conduct, regulations and academic policies of the host university. Any appeal of violations of such policies must follow the procedures of the host university.

Article 12.- While participating in the exchange program at the host institution, the exchange student will be responsible for the cost of travel expenses to and from the host country, accommodation in the host country, all books, equipment, consumables, hospitalization, health insurance, and other incidental expenses. The host institution bears no responsibility for providing funds to an exchange student for any purpose.

Article 13.- Admission and graduation of exchange students shall be made in accordance with the charter and policies of the host institution.

Article 14.- The two universities agree to additionally offer a double degree program governed by the approvals of each program according to annexes.

IV. Joint Research and Others

Article 15.- The institutions agree to carry out joint research on current problems of mutual interest, as appropriate.

Article 16.- Both institutions agree to discuss further other proposals relating to future collaboration and exchange, including the possibility of brief exchange visits, joint publications of research, joint patenting and other similar steps, as appropriate.

Article 17.- The host institution shall not bear any financial responsibility for visiting staff, except as may be arranged and explicitly documented for specific cases.

V. Terms of Agreement



Article 18.- This Agreement is established for a period of five years, effective on the date of its last signing, but may be terminated early by an institution upon written notice to the other institution at least six months prior to termination. The Agreement will be reviewed in its final year by representatives from both institutions and may be extended by mutual written approval of both institutions. In the event of termination, the institutions shall endeavor to minimize the disruption to students then participating in any programs or activities developed under the auspices of this agreement.

Article 19.- Institutions undertake to refrain from using any name, emblem, logo, trademark or other sign associated with the other institution without having previously obtained the written

authorization of the other to do so. In addition, this agreement does not grant either party the right to use other trademarks, trade names or service marks of the other.

Article 20.- If as a result of the collaborative activities defined under the terms of this agreement, results are produced that have the potential to become INTELLECTUAL PROPERTY, both institutions must immediately notify the other institution of the results and bring together the designated representatives in order to establish an equitable and reasonable distribution of property rights and other interests that may arise from it. Such discussions should at all times endeavor to preserve and continue a harmonious relationship between the two parties. All publications resulting from the collaboration between the two institutions must give due recognition to the other institution for their contributions. In addition, the relationship between the two institutions should be mentioned in all courses and formal presentations resulting from collaboration under the terms set forth in this agreement.

Article 21.- Each institution should designate a liaison to oversee and facilitate the implementation of this cooperation agreement. "NSU" appoints the Provost and "UNILIBRE" designate to Chief Executive Officer International and Institutional Relations.

Article 22.- Each institution may propose individual amendments to the proposed agreement, subject to its financial viability.

Article 23.- Issues not stipulated in this contract will be decided by mutual agreement, which must be in writing. Details of these issues may be included in the appendix to this agreement.

Article 24.- Nothing in the agreement shall be executed if the institutions do not have identifiable funds to support the activities.

**ADDENDUM 1
INTERNATIONAL DUAL DEGREE PROGRAM**

Both universities will agree to provide a dual degree program: Students can transfer from one university to another and meet the graduation requirements for undergraduate, master's and doctoral degrees from the host universities. The host university will award their undergraduate degree to eligible students from the other university upon successful completion of the program. In the first two years of study, students from each university will study at their home university with their faculty, and in the last two years of study, students will come to the destination university campus to fulfill the bachelor's requirements for host universities.

Students will be required to meet the host university's minimum credit hour standard to maintain full-time student status. Libre students will be charged the state tuition fee and NSU students will be charged ordinary tuition. Students must complete all the requirements of the destination university such as prerequisites, general education, and core requirements to receive the degree from the destination university. For the student to meet the requirements, the duration of the program may even exceed 2 years. Each program must submit to the annex established for approvals.

Annex 2 includes class transfer tables between the Business Administration and Economics programs of UNILIBRE in all its sections and Northwestern State Business Administration program, as well as the class transfer table between the public accounting program of UNILIBRE in all its sections and the accounting program at Northwestern State University. Annex 3 includes the class transfer table between the Financial Engineering program and the Business Administration program of Northwestern State University of Louisiana
