Northwestern State University College of Business & Technology Continuing Legal Education Seminar, May 9, 2025 Presenter Biographies

Session 1: Ethics

Associate Justice Scott J. Crichton. Having completed a ten-year term as Associate Justice of the Louisiana Supreme Court, Scott Crichton is Of Counsel for the Law Offices of Mary Watson Smith, L.L.C., a firm focused on appellate advocacy in complex areas of civil law. He also serves clients through Scott J. Crichton Law, LLC operating offices in Shreveport and New Orleans; he is both a mediator and arbitrator with the Perry Dampf Dispute Solutions.

While on the State's high court, Scott chaired the court's Executive Committee as well as the Louisiana Judicial College; he was also the court's statutory designee to the Louisiana Sheriffs' Executive Management Institute Board. He is the recipient of the 2022 Judge Benjamin Jones Judges in the Classroom Award and the 2024 President's Award from the Louisiana Judicial College Board of Governors in recognition of his years of service to judicial education.

For five years, as an adjunct faculty member of Tulane Law School, he taught two 3L courses, Advanced Appellate Advocacy and Contemporary Issues in Legal Ethics, publishing coursebooks on each subject. He has also served on the faculty for the LSU Law Center Trial Advocacy Program.

Prior to his election to the Supreme Court, Scott served 24 years as a judge with the First Judicial District Court (Shreveport/Caddo Parish), presiding in both the civil and criminal divisions; from 1980-1990, Scott had an extensive civil and criminal litigation practice.

Scott credits his parents, Tom (owner, hardware store/cattle rancher) and Mary (homemaker and life master, bridge), with teaching and instilling in him the virtues of humility, education, and a commitment of service to community, all of which have guided him throughout life. Scott, age 70, and his wife, Susie, have two sons, both of whom are lawyers, and are enthusiastically expecting twin granddaughters soon!

Associate Justice Cade R. Cole was elected without opposition to the Louisiana Supreme Court in 2025, representing the Third District of Western Louisiana. Previously, he served as Louisiana's first state and local tax judge, overseeing high-stakes tax disputes and leading procedural fairness reforms. A graduate of DeQuincy High School, Tulane University, and Tulane Law School, he excelled academically, earning multiple CALI Awards. After clerking for Justice Jeannette T. Knoll, he practiced complex business and tax litigation in Lake Charles and served as appellate counsel in diverse cases. A trained

mediator from Pepperdine's Straus Institute, he successfully mediated over 1,500 cases and was instrumental in expediting over 10,000 Hurricane Laura lawsuits.

Justice Cole has held various public service roles, including assistant district attorney, city attorney, and city magistrate. He is a board-certified tax law specialist and has chaired the Louisiana Board of Legal Specialization's Tax Law Advisory Commission. His leadership in tax law reform earned Louisiana recognition as the nation's "Most Improved State" by the Council of State Taxation. Active in the legal community, he has served in leadership roles with the Louisiana State Bar Association, the Federal Bar Association, and judicial selection committees. He was honored with the LSBA's Outstanding Service Award for his work in indigent defense funding.

Beyond the law, he supports McNeese student-athletes through the Ranch Collective. Justice Cole and his wife, Rebekah, a former chemical engineer and active school volunteer, reside in Lake Charles with their four children.

Session 2: Mastering Appellate Court Practice and Procedure in Louisiana

Chief Judge Elizabeth Pickett is a highly respected figure in the legal community, known for her extensive experience and unwavering commitment to public service. She graduated from Tulane University with a Bachelor of Arts in History in 1981 and went on to earn her Juris Doctorate from Tulane Law School in 1984. Following her graduation, she practiced law in Many, Louisiana, where she also served as an Assistant District Attorney for the 11th Judicial District - District Attorney's Office from 1984 until 1990. Her early career laid a strong foundation for her future roles in the judiciary.

In 1990, Judge Pickett was elected as a district judge for the 11th Judicial District, serving Sabine and DeSoto Parishes. Her dedication to justice and her fair, balanced approach quickly earned her the respect of her peers and the community. In May of 1997, she was elected to the Louisiana Third Circuit Court of Appeal, a position she held with distinction. Her re-elections in 2002, 2012, and 2022 are a testament to her exemplary service and the trust placed in her by the electorate. On January 1, 2023, she ascended to the role of Chief Judge of the Third Circuit, further solidifying her legacy in the Louisiana judiciary.

Beyond her judicial duties, Chief Judge Pickett continues to contribute to the legal profession through her involvement in various boards and committees. She currently serves on the Board of Governors of the Louisiana Judicial College and the Judicial Budgetary Control Board. Her commitment to these roles underscores her dedication to the continuous improvement of the judicial system and her unwavering commitment to public service. Judge Pickett's career is a shining example of dedication, integrity, and service to the community.

Judge Van H. Kyzar is a distinguished judge on the Louisiana Third Circuit Court of Appeal, known for his deep roots in Natchitoches and his extensive legal expertise. A lifelong

resident of Natchitoches, Kyzar's commitment to his community is evident in both his personal and professional life. He earned his Bachelor of Science in Business Administration from Northwestern State University in 1979, laying a strong foundation for his future legal career. His academic journey continued at the Louisiana State University Paul M. Hebert Law Center, where he received his Juris Doctorate in 1983.

His election to the Third Circuit Court of Appeal, with a term beginning on January 1, 2017, and ending on December 31, 2026, is a testament to his legal acumen and the trust placed in him by the electorate. Session 3: Summary Judgement

Judge Lala Brittain Sylvester, a lifelong resident of Natchitoches and a proud Louisianian, has dedicated her life to serving her community and upholding the law with integrity and compassion. She grew up in Natchitoches, graduated from St. Mary's High School, and went on to earn a Bachelor of Science in General Studies from Northwestern State University in 1982. She later pursued her passion for justice, earning a law degree from Southern University Law Center in 1987.

For more than 20 years, Judge Sylvester practiced law privately and served as an Assistant District Attorney from 2006 to 2014. In 2015, she was sworn in as Judge for Division B of the 10th Judicial District Court, where she continues to serve today. She has been an active member of both the Louisiana State Bar Association and the Natchitoches Parish Bar Association.

Deeply involved in her community, Judge Sylvester has served as president of the Service League of Natchitoches and the St. Mary's Foundation. She also chaired the board for the Natchitoches Regional Medical Center Foundation and its scholarship program. Additionally, she is a member of Beta Sigma Phi, the Natchitoches Historic Foundation, and the American Legion Auxiliary. She holds the distinguished title of Lady of the Holy Sepulchre in the Equestrian Order of the Holy Sepulchre of Jerusalem.

Judge Sylvester is married to Russell "Rusty" Sylvester, and together they have four children: Brittany, Courtney, Ashley, and Kathleen. The Sylvester family are devoted members of Immaculate Conception Catholic Church.

K. Jacob Ruppert was appointed Court Counsel and District Hearing Officer by the judiciary of the 10th Judicial District Court of Louisiana (Natchitoches Parish) in August 2017, after serving in that position for 12 years with the 11th Judicial District Court (Sabine Parish). Ruppert has been an attorney since 1995 and is admitted to the bars of New York, Louisiana, and the District of Columbia.

He received his undergraduate degree from the University of New Orleans (Alpha Theta Epsilon Honor Society) and his Juris Doctor from the City University of New York School of Law (CUNY Law Review, ILSA Journal of International and Comparative Law). Ruppert has been awarded international study scholarships at l'Université Catholique de l'Ouest-Angers in France (French/French Commerce) and Universidad de la Habana (Cuban Legal Studies/Quarantine of HIV Cubanos). He relocated to Central Louisiana as a Hurricane Katrina evacuee, having moved to New Orleans from New York City two months before the storm.

As Court Counsel, Ruppert serves as a legal advisor, researcher, analyst, and writer for the District Court Judiciary in the adjudication of all matters (civil, criminal, juvenile, and family). He writes orders, judgments, opinions, and confidential bench memoranda, and prepares the judiciary with procedural and substantive legal analysis and commentary on pending matters. As District Hearing Officer, he conducts trials in paternity, child support, spousal support, and domestic violence, in addition to conducting conferences in litigation between self-represented litigants.

Ruppert serves on the Louisiana Supreme Court's Self-Represented Litigant Committee and is the current president of the Louisiana Hearing Officers' Association (LaHOA). He is frequently seen educating the state bench and bar on matters of trial practice law and rules, alimentary obligations, and family law.

Ruppert has been an adjunct faculty member with the Department of Criminal Justice at Northwestern State University since 2015, where he continues to contribute to the academic community.

Session 4: Best Practices Before the Louisiana Supreme Court: Insights From Within

Session 5: Immigration and Employment
