<b>Data Analysis:</b>
Cycle 3 (Fall 2024) results will be provided with the Addendum. Across cycles 1 and 2 (Fall 2023 and Spring 2024), candidates agree that the EPP adequately prepared them to demonstrate all InTASC standards in the classroom, as teacher of record. Some candidates personally felt indifferent towards some questions; however, the outcomes indicate that candidates still agreed or strongly agreed, overall. The lowest score of 3.1 (still agree) was represented across InTASC standard 10, indicating a need for more collaboration with stakeholders to ensure learner growth, including families.
<b>Continuous Improvement Based on Data:</b>
In an effort for continuous improvement, the EPP will focus on opportunities for candidates to gain more experiences with collaborating with stakeholders, especially families, to ensure learner needs are met, and to promote and support learner growth.
