**Data Analysis:**

Cycle 3 (Fall 2024) results will be provided with the Addendum. Across cycles 1 and 2 (Fall 2023 and Spring 2024), completers agreed that they were prepared to execute, or support teachers in executing, according to the InTASC standards. The results show positive outcomes for how employers feel the EPP has prepared their completers.

**Continuous Improvement Based on Data:**

In an effort for continuous improvement and more valid feedback, the EPP will continue to focus on gaining greater completer participation, while working to ensure all educators' performance effectively reflects the dynamics of the InTASC standards across all programs. While still proficient, additional emphasis on engaging candidates in implementing assessments in an ethical manner to engage learners in their own growth (InTASC 6) could be an area of focus. Doing so will teach students to be self-monitors of their growth; thus, holding them more accountable for their learning.
