## **Data Analysis:**

Cycle 3 (Fall 2024) results will be provided with the Addendum. Across cycles 1 and 2 (Fall 2023 and Spring 2024), there was a low response rate from employers of advanced completers. However, employers agreed that candidates employed in the field were prepared to execute or support teachers in execute according to the InTASC standards. The results still show positive outcomes for how employers feel the EPP has prepared their employees.

## **Continuous Improvement Based on Data:**

In an effort for continuous improvement and more valid feedback, the EPP will focus on gaining greater employer participation, while working to ensure all educators' performance effectively reflects the dynamics of the InTASC standards across all programs.
