Northwestern State Student Technology Fee shall be dedicated to the acquisition, installation, maintenance, and efficient use of state-of-the-art technology solely for the purpose of supporting and improving student life and learning, and to better prepare its students for the workplaces of the twenty-first century. Student involvement is critical to the successful administration of the Technology Fee and a committee comprised of elected and appointed current students oversee the fund. The standing committee is composed of the Student Government Association (SGA) President from the Natchitoches campus, the SGA President from the Shreveport campus, the SGA Treasurer from the Natchitoches campus, the SGA Treasurer from the Shreveport campus, two student representatives nominated by the SGA president from the Natchitoches campus, one student nominated and approved by the Leesville campus Director, and one student nominated and approved by the Cenla campus Director.

The mission of the Student Technology Advisory Team is to ensure that all students have easy access to technologies that are necessary to adequately prepare them to successfully compete in the job market. The Student Technology Fee is a student self-assessed fee that should be used exclusively to the direct benefit of the students.
