ADDITIONAL GRADUATION REQUIREMENT

- 50% of the School of Business classes must be completed at Northwestern State University. Grades of "CR" do not count towards the 50%.
- To sit for the Louisiana CPA, you need to have 150 credit hours.

Must maintain a 2.0 GPA within Major and Concentration to graduate.

NOTE: Requirements to sit for the Louisiana CPA exam:

- 150 credit hours
- Bachelor's degree from accredited university
- 24 hours of Accounting courses including Intermediate (6 hours), Cost (3 hours), Income Tax (3 hours), Auditing (3 hours), and 9 hours of accounting electives
- 24 hours of Business courses including Business Law (3 hours) and 21 hours of qualifying business courses

Courses taken outside of a student's degree program are not eligible for Title IV federal financial aid (grants and loans).
