**Electronics** (141A): (20 semester hours): Electronics Engineering Technology 4310-4311, 4350-4351, 4390, 4950 or Industrial Engineering Technology 4960; Industrial Engineering Technology 2790, 3740; and three additional hours of technical elective<sup>1</sup>.

**Biomedical (141B):** (23 semester hours): Biomedical Engineering Technology 3320-3321, 3370-3371, 4390-4391, 4950 (43 hours); Industrial Engineering Technology 3740; Biology 2250-2251, 2260-2261.

### **Curriculum for Electronics Engineering Technology (141)**

- 1<sup>st</sup> year <u>Delete</u>: MATH 2130, 2140 (6 hrs.) Add: Chemistry<sup>4</sup> (3 hrs.), ENGL 1020 (3 hrs.)
- 2<sup>nd</sup> year <u>Delete</u>: Biological Science<sup>2</sup> (0-3 hrs.), ENGL 1020 (3 hrs.), EET concentration area<sup>3</sup> (3-8 hrs.)

  <u>Add</u>: Mathematics 2130, 2140 (6 hrs.), EET concentration area<sup>3</sup> (3-4 hrs.)
- 3<sup>rd</sup> year <u>Delete</u>: Chemistry<sup>4</sup> (3 hrs.), EET 4390, EET concentration area<sup>3</sup> (8 hrs.)

  <u>Add</u>: Biological Science<sup>2</sup> (0-3 hrs.), EET concentration area<sup>3</sup> (11-16 hrs.)
- 4th year <u>Delete</u>: EET concentration area (7-9 hrs.)

  <u>Add</u>: Industrial Engineering Technology 3740 (3 hrs.), EET concentration area<sup>3</sup> (3-6 hrs.)

#### Footnotes

- 1 Technical electives may be selected from any Biomedical Engineering Technology, Computer Science, Electronics Engineering Technology, or Industrial Engineering Technology courses, or Mathematics 2050. Electives may include a minimum of three hours of occupational field experience.
- 2 Students in the Biomedical concentration must take the Biology courses specified within the concentration, students in the Electronics concentration area must meet the University core curriculum requirements for biological science.
- 3 Chosen from concentration area.
- 4 Students can take a CHEM 1030, CHEM 1070 or SCI 1010.
- 5 Must meet the University core curriculum requirements.
