I. Department of Theatre and Dance

A. Delete Musical Theatre concentration (245C). (Effective Fall 2026)

Action: Approved without opposition

II. School of Social Sciences and Applied Programs

A. Add the following new courses for undergraduate credit: (Effective Fall 2026)

- CJ 2800 – Juvenile Justice Process (3-3-0)
- CJ 2110 – Introduction to Criminology (3-3-0)

B. Revise the Criminal Justice (250) curriculum as follow: (Effective Fall 2026)

- **Criminal Justice Major Requirements: (66 semester hours)** students seeking a major in Criminal Justice must complete 66 semester hours within the 120 semester hour Criminal Justice Curriculum, which include Criminal Justice 1100, 2300, 2400, 2500, 2600, 2110 or 3040, 2800, or 3090, 3355, 3380, three hours of advanced Criminal Justice (courses at 3000-level), 4200, 4475, 4480, and twelve hours of advanced Criminal Justice (courses at 4000-level), Sociology 1010, 3030 or 3230, 4080. English 3230 or Organizational Leadership 3170, and Political Science 3090.

However, students seeking the Pre-Law and Paralegal Studies Concentration will take PLPS 4020 in lieu of CJ 4200 and PLPS 4090 in lieu of CJ 4480.

Curriculum for Criminal Justice (250)

2nd year - Delete: PSYC 2450 (3 hrs.)

Add: CJ 2110 or CJ 3040 (3 hrs.)

3rd year - Delete: CJ 3040 (3hrs.), CJ 3090 (3 hrs.) and CJ 3360 (3 hrs.)

Add: CJ 2800 or CJ 3090 (3 hrs.), SOC 3030 or SOC 3230 (3 hrs.), 3000-level Advanced CJ Elective⁴ (3 hrs.)

4th year - Delete: CJ 4250 (3 hrs.), CJ 4450 (3 hrs.), CJ 4460 (3hrs.), and CJ 4500 (3 hrs.)

Add: 4000-level Advanced CJ Elective⁴ (12 hrs.)

Footnotes:

Add: ⁴ An advanced Criminal Justice Elective is any Criminal Justice, Unified Public Safety Administration, or Pre-Law and Pre-Legal Services course at the specified level.

III. Department of Music

A. Add the following new courses for undergraduate credit: (Effective Fall .2026)

- MUS 2890 – Principles of Sound Mixing (3-3-0).
- MUS 2880 – Concert Management and Promotion (3-3-0).

- MUS 2870 – Pro Tools (3-3-0).
- MUS 2860 – Survey of Music Business (3-3-0).

B. Revise the Bachelor of Music (242) concentration in Music Business (242E) as follows: (Effective Fall 2026)

- **Music Business (242E):** Music 1710 for four semesters (8 credit hours), MUS 3710 for two semesters (4 credit hours), ~~6 8~~ hours of ensembles, 4 credit hours of piano, to be chosen from MUS 1800, 1810, 1820, 1830, 1700A, 1710A; MUS 4200, MUS 4400, MUS 4720 (minimum 1 credit hour), ACCT 1040 or ECON 2010, COMM 2040, BUAD 3280, MUS 4730, **MUS 2860; Choice of MUS 2870, 2880, or 2890.** ~~6 credit hours of MUS 2990, must include subtopic 01 Survey of Music Business; 2 credit hours of music elective, for a total of 46 hours.~~

Furthermore: Students must take ECON 2000 to fulfill Social Science core requirements. Students must take MUS 4200 in lieu of MUS 4060. Students may take 2 credit hours of **MUS 1700 in lieu of either MSU 2030 or MUS 2040; or Students may take MUS 3500, 3600, 3700 or 4130 plus 1 hour of MUS 1700 (3 credit hours) in lieu of MUS 2030 and 2040. music elective in lieu of MUS 2030. Students may take MUS 4130 or 4060 (3 credit hours) in lieu of MUS 2040 (2 credit hours) and 1 credit hour of music elective.** In lieu of foreign language requirement, students must take ~~6~~ 3 hours from: BUAD 1040, BUAD 2200, MGT 2500, MKTG 3230, **COMM 2400, COMM 2440, THEA 3390, and 3 hours from MUS 4740, 2870, 2880 or 2890. BUAD 3250, BUAD 3260, BUAD 3280, or an additional MUS 2990.** Students may take MUS 2170 in lieu of MUS 2160 and 2161; students may take **MUS 4070 3500, 3600, or 3700, in lieu of 4010.**

C. Revise Footnotes for the Bachelor of Music (242) as follows:

- **Footnotes:**
 - 5 For Performance Concentration, piano students must take 4 hours in music electives other than piano, and vocal students must take 3 hours of diction from MUS 1230, 1220, 1210 and 3 hours in MUS 4270. Instrumental students may take music elective in MUS 1700, 1300, 1310, 1320, 1330, 1340, 1350, 1360, 1370, 1380, 1390, 1400, 1410, 1420, and 1430. For Sacred Music concentration, students whose primary instrument is voice must enroll in 2 hours of MUS 1700 piano lessons; Keyboard students must enroll in 2 hours of MUS 1700 voice lessons. For Music Business concentration: **3 hours must be MUS 3860 and 3 hours must be chosen from MUS 3870, 3880, 3890. at least 6 hours must be in MUS 2990 Special Topics.**
 - 9 Music Business students may take **2 hours of MUS 1700 in lieu of MUS 2030; or 1 hour MUS 1700 and choice of MUS 2500, 3600, 3700, 4130 in lieu of MUS 2030 and MUS 2040. MUS 4060 or 4130 in lieu of MUS 2040 plus 1 credit hour of music elective.**
 - 10 **Music Business students may take MUS 4070 in lieu of 4010. Music Business students take 2 hours of music electives in lieu of ensembles during the fourth year.**
 - 11 **Music Business students may take MUS 3500, 3600, or 3700 in lieu of 4010.**

NOTE: Proficiency requirement in major performance area must be satisfied prior to being admitted to 3710-level study. Music majors must earn at least a “C” (2.0) in each music course in order for those courses to be credited as completed prerequisites or to count as graduation requirements.

NOTE: All students enrolled in MUS 1710 and MUS 3710 are required to participate in an end-of-semester jury, performing for faculty members appropriate to the student’s instrument/voice category.

IV. School of Education

- A. Make the following course changes: (Effective Spring 2026)
 - CFS 2090 – revise description
 - CFS 3700 – revise description
- B. Revise Major Requirements: (Effective Fall 2026)
 - **Child and Family Studies Major Requirements:** Students seeking a major in Child and Family Studies must complete 35 semester hours of CFS major requirements, along with 24 CFS concentration hours within the 120-semester hour CFS curriculum. Major requirements include CFS 1070, 2000, 2040, 3020, 3030, 3500, 4010, 4160 and 4500. (***Child Welfare concentration students will take SOWK 4190 in lieu of CFS 4500;** HED 1010, and PSYC 2050. Students must earn a grade of “C” or higher in all requirements and concentration coursework.
 - **Available Concentrations (one required):**
- C. Revise Child Development and Family Relations (137E): (Effective Fall 2026)
 - **Child Development and Family Relations (137E):** (24 semester hours) CFS 2090, 2500, 3700, 4080, or 4140; NUTR 1030 or 1070; SPED 3460, **ECED 3040, and ECED 3050.** Students must earn a grade of “C” or higher in all concentration coursework.
- D. Add new areas of concentration: (Effective Fall 2026)
 - **Child Welfare (137G):** (24 semester hours) CFS 3700, AS 1010, NUTR 1070, PSYC 3200, SOWK 4230, SOWK 4260, SOWK 4270, SOWK 4200. Students must earn a grade of “C” or higher in all concentration coursework.
 - **Child Day Care Coaching (137H):** (24 semester hours) CFS 3700, CFS 2090, NUTR 1070, MGT 2500, ABA 3100, ABA 4200, SOWK 4200, PSYC 3200. Students must earn a grade of “C” or higher in all concentration coursework.

E. Add new minors: (Effective Fall 2026)

- **Child Welfare Minor Requirements (MI87):** (21 semester hours) CFS 3700, AS 1010, SOWK 3200, SOWK 4190 (internship) or NUTR 1070 and PSYC 3200, SOWK 4270, SOWK 4200. A grade of “C” or better is required for all CFS minor courses.
- **Child Day Care Coaching Minor Requirements (MI 73):** (21 semester hours) CFS 3700, CFS 2090, MGT 2500, ABA 3100, ABA 4200, SOWK 4200, PSYC 3200. A grade of “C” or better is required for all CFS minor courses.
