MEMORANDUM OF UNDERSTANDING BETWEEN

NORTHWESTERN STATE UNIVERSITY OF LOUISIANA

AND

KILGORE COLLEGE OF KILGORE, TEXAS

Northwestern State University of Louisiana (NSU) and Kilgore College of Kilgore, Texas have agreed to enter into a Memorandum of Understanding for a 2 + 2 program between the two institutions. The 2+2 program will allow students to complete two years of study at Kilgore College and then transfer all credit hours as designated in Appendix A to NSU for completion of the Bachelors of Social Work degree (BSW). Students transferring to NSU may complete the last two years of their course work (including the required field placement) at the NSU campus. Both the university and the college serve the needs of the constituency and are responsive, student oriented institutions that prepare the students to become productive members of society as well as promote the academic development and improvement in the quality of life of citizens in their regions.

This partnership is mutually beneficial to both institutions for several reasons. Traditional and non-traditional students attending Kilgore College will have the opportunity after completing core requirements at Kilgore College to transfer to an accredited BSW program that will accept Kilgore College credits, including credit for one of two introductory social work courses. NSU will have the opportunity to accept students into the BSW program who are well prepared with foundation course work.

Both the university and the college are accredited by the Southern Association of Colleges and Schools.

Both the university and the college have full-time, tenure track faculty with advanced academic and professional credentials.

Both the university and the college have support resources (i.e., library, on-line access, service courses, and adequate administrative-faculty-staff backup).

In accordance with this Memorandum of Understanding, Kilgore College agrees to:

Provide academic advising to students who plan to transfer to NSU according to agreements in Appendix Λ .

Have Kilgore College students who intend to transfer to NSU sign the Intent to transfer form and mail the completed form to NSU. (Appendix B)

Provide students the opportunity to obtain the Kilgore College credit hours as listed in Appendix A of the Memorandum of Understanding between NSU and Kilgore College.

Provide transferring students assistance in completing a NSU BSW Application for Admission into the Professional Social Work Program.

Jointly market the 2 + 2 agreement with NSU.

In accordance with this Memorandum of Understanding, Northwestern State University agrees to:

Receive and maintain "Intent to Transfer" forms from Kilgore College students and honor the agreement regarding academic catalog in effect on the date of the student's signature and the NSU confirmation signature. (Appendix B)

Accept Kilgore College credit hours as listed in Appendix A of the Memorandum of Understanding between Northwestern State University and Louisiana State University at Alexandria.

Provide Kilgore College with Copies of the Application for Admission into the Professional Social Work Program and other advising materials.

Provide information about the 2+2 Agreement in the Northwestern State University catalog.

Jointly market the 2+2 agreement with Kilgore College.

Terms and Conditions:

- 1. This Articulation Agreement becomes effective upon signing by both institutions and either may publicize the partnership or any successful collaboration between the two (2) institutions resulting from the initiatives within this agreement. Copies of press releases relating to any part of this Agreement must be made available to the designated News and Information/Public Relations Office at the partnering institution.
- 2. This Articulation Agreement will be reviewed every three (3) years. Any amendments must be proposed in writing and be approved by the President of each institution, or their designees.
- 3. This Articulation Agreement shall remain effective until one (1), or both, institutions deem it necessary to terminate it. The desire to terminate the Agreement must be submitted in writing to the President of the partnering institution.
- 4. Both institutions will designate individuals who will be responsible for the maintenance of this Agreement. In the event that the designated individuals are no longer available to perform this duty, the replacement will be communicated in writing to the other institution, but this will not require a renegotiation of the Agreement.
- 5. NSU will encourage Kilgore College transfer students to complete the appropriate Associate Degree either before matriculation to NSU or by reverse transfer of course credit following admission to and attendance at NSU.
- 6. NSU agrees to provide transfer students with information regarding the availability of transfer scholarships for eligible students (including waiver of out-of-state tuition) as well as other financial aid opportunities at NSU.
- 7. Representatives from Kilgore College and NSU will meet or make contact at least once per year to exchange course catalogs and discuss current transfer admission information to be used during the subsequent academic year.
- 8. Kilgore College will publicize and help facilitate campus visits by NSU recruiters and will prominently display NSU posters and literature.
- 9. This Articulation Agreement shall be filed with the Offices of the President and Provost at both institutions as well as with the Offices of Admissions and Registrar at each institution.
