

AGREEMENT

**The University of Louisiana System
and
The Texas State University System**

In accordance with actions of the Board of Supervisors for the University of Louisiana System (January 11, 2002), the Texas *Education Code*, and the rules of the Texas Higher Education Coordinating Board, *Volume 19, Texas Administrative Code, Section 21.26*, this is to confirm that the University of Louisiana System (Grambling State University, Louisiana Tech University, McNeese State University, Nicholls State University, Northwestern State University, Southeastern Louisiana University, University of Louisiana at Lafayette, and University of Louisiana at Monroe) will assess tuition at its in-state rates for certain Texas residents; the Texas State University System components (Angelo State University, Lamar University, Lamar Institute of Technology, Lamar State College-Orange, Lamar State College-Port Arthur, Sam Houston State University, Southwest Texas State University, Sul Ross State University, and Sul Ross State University Rio Grande College) will assess tuition at their in-state rates for certain Louisiana residents. The authority cited in this letter shall be attached and incorporated into and become part of this agreement for all purposes.

The undersigned represent that they have authority to bind their respective institutions and that facsimile signatures shall have the same binding effect as originals.

RE: Tuition Reciprocity – ULS & Texas State University System Board of Regents

Pursuant to the actions of the Board of Supervisors for the University of Louisiana System on January 11, 2002, Northwestern State University will implement the tuition reciprocity for Texas residents as outlined in the agreement by and between the ULS and Texas State University System Board of Regents.

For a student to be eligible for this exemption of out of state fees they must be a resident of one of the following Texas border counties: Cass, Marion, Harrison, Panola, Shelby, Sabine, Newton, Orange or Jefferson. Additionally, the student will have to furnish at least one of the following documents indicating residence in one of the aforementioned counties:

1. A copy of a permanent (laminated) Texas Driver's License that is at least 12 months old.
2. A valid Texas Voters Registration Card, which is at least 12 months old.
3. A notarized letter from an employer(s) on company letterhead, verifying employment in Texas for at least twelve months prior to registration.
4. A copy of a lease agreement *in the student's name* for at least 12 months prior to registration.
5. A copy of a property deed and/or current tax statement showing residency for at least 12 months prior to registration.
6. An official transcript from a Texas high school showing attendance or graduation within the past 12 months.
7. Canceled checks, telephone bills, or utility bills *in the student's name* covering each of the twelve months prior to registration.
8. Other Documentation which would prove residency in Texas for at least 12 months prior to registration.
