

MEMORANDUM OF UNDERSTANDING

BETWEEN

Northwestern State University

AND

South Louisiana Community College

NSU ADMINISTRATION

Northwestern State University (NSU) and South Louisiana Community College (SLCC) have agreed to enter into a Memorandum of Understanding for a 2+2 program between the two Institutions. The 2+2 program will allow students to complete the Associate of Science in Criminal Justice (Law Enforcement Concentration) at SLCC and transfer credit hours applied to the Criminal Justice degree as listed in Appendix A to Northwestern State University in partial fulfillment of degree requirements for the Bachelor of Science Degree in Unified Public Safety Administration Concentration A: Law Enforcement Administration at NSU. Both institutions serve the needs of their constituency and are responsive, student oriented institutions that prepare their students to become productive members of society as well as promote the academic development and improvement in the quality of life of citizens in their regions.

This partnership is mutually beneficial to both institutions for several reasons. Traditional and non-traditional students attending SLCC have said that they want and need an opportunity after completing their criminal justice studies from SLCC to transfer to a related baccalaureate degree program.

Both institutions have full-time, faculty with advanced academic and field experience credentials.

Both institutions have extensive support resources (i.e., library, on-line access, service courses, and adequate administrative – faculty – staff backup).

Northwestern State University has notable on-line instructional programs. The Unified Public Safety Administration baccalaureate degree is one example of available programs via the internet. Building a 2 + 2 degree will provide a model well suited to the students' interest and learning styles.

Northwestern State University has a partial tuition exemption for students employed full-time as law enforcement officers enrolled as Criminal Justice majors.

In accordance with this Memorandum of Understanding, South Louisiana Community College agrees to:

Have SLCC students who plan to transfer to NSU complete a Bachelor Degree in Unified Public Safety Administration Concentration A: Law Enforcement Administration file an intent to transfer form with NSU to establish the catalog of record for their graduation from NSU.

Jointly with Northwestern State University, market the 2+2 Agreement to prospective students.

Provide information about the 2+2 Agreement in the South Louisiana Community College catalog.


SLCC will offer credit hours as listed in Appendix A of the Memorandum of Understanding between NSU and SLCC for students.

Accept South Louisiana Community College credit hours as listed in Appendix A of the Memorandum of Understanding between Northwestern State University and South Louisiana Community College.
