The Academic Calendar Sub-Committee meeting was called to order at 10:23 a.m. on March 17, 2016, in the 3rd Floor Conference Room of the Student Services Center for the purpose of selecting one or two of the summer session scenarios listed below for testing in the Banner System:

Item #1 - Scenario #1 - Current Summer Sessions – 12-Week, 8-Week, & two 4-Weeks

May 15, 2017

- 12 week session
 - May 16 – resign with 100% refund
 - May 18 – resign with 50% refund

June 5, 2017

- 1st 4 week session begins
- 8 week session begins
 - June 6 – resign with 100% refund
 - June 8 – resign with 50% refund

July 3, 2017

- 2nd 4 week session begins
 - July 4 – resign with 100% refund
 - July 6 – resign with 50% refund

The discussion on all scenarios was conducted in great detail. After a very lengthy discussion, Item #1, Scenario #1, was approved. There was no opposition to this decision. The sub-committee members expressed that this decision was based on the views or opinions conveyed to them by faculty members and students addressing the topic of courses being offered during the summer.

The sub-committee members summarized that the major factors in their decision were the expensive cost of classes for students for summer sessions and faculty members' concerns about salary compensation for low enrollment for summer sessions.

Item #1, Scenario #1, was **approved** by a majority vote without any opposition.
