NSU Request for Prior Approval of Transfer Credit

Any student who is currently enrolled at NSU and wishes to take coursework at another institution or by correspondence is required to fill out a "Request for Prior Approval of Transfer Credit" form. Students may not receive credit for work taken concurrently at another college or university **without** prior written approval from their academic dean. The following regulations govern the taking of coursework elsewhere or by correspondence:

- Permission to take courses elsewhere will be granted only to students who are or have been enrolled at NSU.
- Permission will not be granted to students who are on academic suspension.
- The student must provide the course number of the NSU course for which he or she is seeking equivalent credit.
- A University Registrar's Office evaluator will provide the equivalent course number for the institution the student plans to attend.
- The student's Dean has the final approval for the student to take the course elsewhere.
- Twenty-five (25%) of the semester hours required for the degree at NSU must be earned through instruction at NSU.
- It is the student's responsibility to see that an official transcript is mailed to NSU by the other institution.
