---

1. Describe target audience.

Every student enrolled on the NSU Leesville/Fort Polk campus will benefit from the requested items. NSU Leesville/Fort Polk averages around 900 students during the Fall and the Spring semesters and about 300 during the Summer semester. Approximately 60-70% of the students are civilian, 20-30% are military family members, and 10% are active duty military. Classes are scheduled Monday – Friday during the day and Monday – Thursday evenings.

Core and upper level History and Social Science courses are usually scheduled into room 4 in Bldg. 551. Approximately 200 students enroll in variety of History and Social Science courses each semester. These include History 1010, 1020, 2010, 2020, upper level history courses, geography, Political Science 2010 and 2020, and Sociology 1010. This classroom is also use by other disciplines

This would impact approximately 450 students enrolled in core courses each year.

This would also impact additional classes scheduled into classroom 4.

Classroom 4 has 60 seats and can have 7 classes meeting per day so potentially 420 students would benefit daily from this equipment.

2. Describe project/initiative for which you are requesting funds.

To create a smart classroom on the NSU Leesville campus in room 4 bldg. 551.

To purchase a symposium, computer, presentation projector large screen, VCR/DVD, ELMO projector, and a locking cabinet to secure this equipment in room 4.

To purchase Office Professional license for the computer in the Smart Cart.

To purchase a 42" LCD panel for the Student Union located in bldg. 552.

To purchase a microwave for the Student Union located in bldg. 552.

To purchase a ParScore scantron located in room 102B bldg. 550.

3. State measurable objectives that will be used to determine the impact/effectiveness of the project.

To provide technology that will enhance the presentation of instruction for history and social science classes by

- Capability of 3-D demonstrations
- Using the internet sources in the classroom
- Ability to access the internet easily from the classroom.
- Ability to use PowerPoint presentations for History and Social Science classes.
- enhance the viewing of VCR tapes and DVDs in the classroom

To improve the understanding of concepts presented using the symposium, computer, ELMO, and presentation projector on the large screen.

To improve the Student Union area for students on the NSU Leesville campus by providing a 42" LCD Panel and microwave to the student union area.

To provide better feedback for students and shorten the time for students to review test results.

4. Indicate how each project objective will be evaluated.

Students using this equipment will complete a survey:

- Evaluating the equipment in the various rooms,
- Rate the quality and comparing their understanding of the concepts presented with this new technology to previous methods i.e. chalkboard/whiteboard and overheads.

Instructors using this equipment will complete a survey:

- Evaluating the equipment in this room,
- Comparing their opinion of student understanding of concepts presented with this new technology to previous methods i.e. chalkboard/whiteboard and overheads.

5. Provide a justification for funding of the project. Estimate the number of students that will be served per academic year and in what ways. Please indicate also any unique needs of the target group.

The SMART Expression 503 Multimedia Cabinet is an interactive lectern that links the computer to the projector and allows the students to view the computer monitor. This cabinet contains a Symposium which has an interactive console with a stylus and touch screen. The instructor simply touches the screen to control applications and write electronically on the touch screen allowing students to easily follow along with the lecture.

This technology will improve the clarity of concepts taught in the various disciplines by the use of multimedia presentations. Presentation of business instruction will be enhanced by the drawing capabilities of the Symposium. PowerPoint presents will be enhanced by the projection and drawing capabilities of the Symposium. VHS/DVDs will also enhance the classroom instruction.

The ELMO gives the ability of an entire classroom to have a close-up view of the instructor's demonstration. Internet access will enhance instruction by access to video clips and internet sources for history and social science classes by

- Historical documents and objects can be viewed by the entire class
- Visualization of material/concepts
- Capability of 3-D demonstrations
- Using the internet sources in the classroom
- Ability to project documents on the large screen for critic and commentary

This would impact approximately 500 students enrolled in classes in this room each year.

The current Student Union area is located in Bldg. 552 across from the Bookstore. This area is the only social gathering place for students on the Leesville campus. It has several tables with chairs and is adjacent to several vending machines. There is an older television located in this area. Students are requesting and would appreciate having a 42" LCD Panel Television and a microwave. Currently, there is no place on the Leesville campus where students can purchase hot meals. The microwave would allow them to heat meals brought home. A wall is being removed to enlarge this area. The LCD Panel and microwave would make the Student Union area more comparable to other campuses.

The scantron that will mark the test for students to compare with their paper test. This scantron will provide better feedback for students and shorten the time for students to review test results.

Tommy Tilley, Senior User Support Specialist, and the Office of Student Technology will work together to support this equipment.

All rooms on the Leesville campus are wired for internet access so wiring is not necessary.

Electrical switches will need to be installed by Plant Facilities for the electric screens.

Equipment will be ordered in September and arrive by the end of October.  
During the fall 2007, the equipment will be installed in the classrooms and tested.  
Instructors will begin using the equipment after the installation is complete.

Evaluation will be done by surveys to students and instructors at the end of the semester.

10. Estimate the expected life of hardware and software. Explain any anticipated equipment/software upgrades during the next five years.

Any upgrades in SMART software can be downloaded from the website.  
The SMART Symposium is expected to last from 5-10 years if used properly.  
The life of the computer is five years.  
ELMO has a life of 5 years.  
VCR/DVD player has a life of 5 years.  
Large projector screen should last 10-15 years.  
LCD Panel should last 5 years.  
ParScore scantron should last 5 years.

ParScore -Scantron will be located in room 102B. The key will be controlled under the NSU Leesville/Fort Polk Key Control Policy.

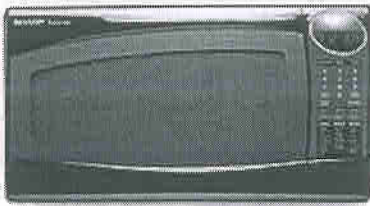

## SOFTWARE LICENSING

**Single User** - Unless otherwise indicated, Scantron Software is licensed for a single user only. Single user permits a customer to use one copy of the software program on a single computer. The software is in "use" when it is loaded into temporary memory (i.e. RAM) or installed into permanent memory (e.g., hard disk, CD-ROM, or other storage device) of that computer. Installation onto a network server is not permitted under this type of license.

**Network (LAN)** - Allows customer to install software on a single network server. Unless otherwise indicated there is no limit to the number of concurrent users.

**Site License:** Permits a limited number of users at a single site. A site is defined as follows: Commercial customer = a single building. K-12 education users = a single building. Colleges and Universities = a single department in a single building on a single campus. Various site license options are offered. Site licenses apply to single user software applications. They do not apply to LAN-based software.

### Local Area Network Licensing

ParSCORE for Windows has the ability to be licensed on a Local Area Network (LAN), and the structure used accommodates a variety of different sizes of customer, allowing them to fit the quantity of users to their particular environment needs. This allows a more economical approach when the needs are small, yet represents the true value of the product as requirements grow. The user count is based upon the number of physical users, i.e. how many users can be on the system according to their license. For example, a university may have a need for twenty people to access the system. Therefore, the university must have the level of license that covers all twenty of their users.

The number of users is controlled by an access code provided when the software is shipped. This access code can be changed at a later date to increase the number of users, if required.

Software Maintenance for a site license customer is incorporated into the initial site license fee, and in the annual renewals. This fee provides the same level of support they would get under a separate software maintenance agreement.

No site license is available for LAN or network-based software. By its nature, multiple users on the network already have access from any workstation on the network. Therefore, a network site license is unnecessary.

An academic site is defined as a single building when referring to K through 12 environments, and a single department in a single building on a single campus for higher education institutions. A commercial institution is defined as a single building.
