Northwestern's Student Technology Fee Committee

Northwestern's Student Technology Fee Committee was established in the summer of 1997. The Committee is currently comprised of the Student Government Association Presidents and Treasurers from the Natchitoches and Shreveport campuses, a student representative from the Leesville campus and two other student representatives appointed by the Natchitoches SGA President. Meetings are held when requested by the SGA President (STAT Chair). The mission statement of the Student Technology Advisory Team is as follows:

The mission of the Student Technology Advisory Team is to ensure that all students have easy access to technologies that are necessary to adequately prepare them to successfully compete in the job market. The Student Technology fee is a student self assessed fee that should be used exclusively to the direct benefit of the students. In addition, students should have the primary role in the governance and allocation of these funds.

Progress made during 2016-2017

A total of \$1,187,407 was collected during Fiscal Year 2016-2017 making a total available of \$2,114,598. Expenditures for 2016-2017 were \$1,233,142.

The following is a summary of major projects and expenditures:

Instructional Technology Lab Assistants/Coordinators, Instructional Technology Technical Support Specialist, and Associate Director - \$354,693.

Computer lab equipment, technology projects (large and small), software, supplies, infrastructure and maintenance cost included - \$878,449.

The instructional technology assistants and coordinators were utilized in a multitude of capacities through this past year some of which include:

Staffing and keeping supplies on hand for all open computer labs.

The STAT and Student On-line Support Help Desk web sites were maintained.

The Student Help Desk assisted students with username and password assistance, Moodle, wireless instructions software related issues, email and WebEx.

Professional development is conducted at the beginning of each semester for all Student Technology Fee lab assistants. Student Technology Fee workers are required to attend the training to discuss any current lab issues and maintain a working knowledge of software.

All hours, contact information and maps are posted to the website for viewing and workstation availability.

During Freshman Connection, the technology assistants assisted incoming freshmen with ensuring their myNSU accounts were created during the application process.
