Minutes:

- Reviewed and approved the Minutes from 11 Jun 2020.
- I have updated the University Assessment Committee Membership. Bob Jordan will now join the UAC to represent Student Support Services.
- Reviewed the IE Model Planning Calendar, highlighting key dates and activities.
- The AC 2020-2021 Assessment Tracker is attached. Members are to review it and provide any updates in personnel and or programs to Frank Hall. (Tracker Attached)
- As part of the after-action review of last year's assessment cycle, Dr. Handel addressed the group highlighting his appreciation for the hard work dedicated to this effort, the resulting award of EIA, and the importance of assessment to the University. He applauded the improvements made over the past four years and reinforced that assessment is now a process ingrained in what the University routinely does. EIA logo/badge is attached.
- The group discussed the AC 2019-2020 Assessment Lessons learned. Dr. Pharris mentioned the importance of having an internal transition process to facilitate the introduction of new personnel into critical positions.
- Dr. McAlister suggested we develop some standardized language to capture the impact of COVID-19 on assessment across the University. (Slides Attached)
- The Next Meeting is planned for 12 Nov 2020.

Core competencies:

- The need to integrate dual enrollment students into the University assessment process was discussed.
- Integrating Pineville HS is the priority effort. However, HS students taking our dual enrollment courses taught by high school credentialed faculty in other HS must also be brought into the assessment process.
- The following suspense dates were agreed upon to integrate HS students into our assessment process:
 - 15 Oct 20 All tools (pre/posttest, quizzes, writing assignments, etc.) will be uploaded into the Moodle course shells, and contact with instructors should be made.

- We agreed to meet in early November to discuss the status of the above requirement (looking at 5 Nov at 3:00 via WebEx Invite to follow).
- 1 Dec 20 All assessment results are return to NSU.
- Julie Longlois, Coordinator Carl Perkins Program will assist competency coordinators in establishing points of contact at Pineville and or other high schools as required. The below reflects the courses being taught at Pineville this fall. These are the courses we should be assessing:

- The integration of dual enrollment students into the assessment process will take time. Moving forward, 1 Sept will be the suspense to have tools uploaded in HS Moodle course shells and 1 Dec for schools to return their assessment results. The predictable pattern will facilitate a more comprehensive assessment of the University Core Competencies.
