MEMORANDUM OF UNDERSTANDING (CJ)

BETWEEN

Northwestern State University

AND

South Louisiana Community College

NSU REGISTRAR

Northwestern State University (NSU) and South Louisiana Community College (SLCC) have agreed to enter into a Memorandum of Understanding for a 2+2 program between the two Institutions. The 2+2 program will allow students to complete the Associate of Science in Criminal Justice at SLCC and transfer credit hours applied to the Criminal Justice degree as listed in Appendix A to Northwestern State University in partial fulfillment of degree requirements for the Bachelor of Arts Degree in Criminal Justice at NSU. Both institutions serve the needs of their constituency and are responsive, student-oriented institutions that prepare their students to become productive members of society as well as promote the academic development and improvement in the quality of life of citizens in their regions.

This partnership is mutually beneficial to both institutions for several reasons. Traditional and non-traditional students attending SLCC have said that they want and need an opportunity after completing their criminal justice studies from SLCC to transfer to a related baccalaureate degree program.

Both institutions have full-time faculty with advanced academic and field experience credentials.

Both institutions have extensive support resources (i.e., library, on-line access, service courses, and adequate administrative – faculty – staff backup).

Northwestern State University has a partial tuition exemption for students employed full-time as public safety officials enrolled as Criminal Justice majors.

In accordance with this Memorandum of Understanding, South Louisiana Community College agrees to:

Have SLCC students who plan to transfer to NSU complete a Bachelor Degree in Criminal Justice file an intent to transfer form with NSU to establish the catalog of record for their graduation from NSU.

Jointly with Northwestern State University, market the 2+2 Agreement to prospective students.

Provide information about the 2+2 Agreement in the South Louisiana Community College catalog.

SLCC will offer credit hours as listed in Appendix A of the Memorandum of Understanding between NSU and SLCC for students.

In accordance with this Memorandum of Understanding, Northwestern State University agrees to:

Accept South Louisiana Community College credit hours as listed in Appendix A of the Memorandum of Understanding between Northwestern State University and South Louisiana Community College.

Along with South Louisiana Community College, jointly market the 2+2 Agreement.
