

MEMORANDUM OF UNDERSTANDING (UPSA)

BETWEEN

Northwestern State University

AND

Louisiana State University at Eunice

Northwestern State University (NSU) and Louisiana State University at Eunice (LSUE) have agreed to enter into a Memorandum of Understanding for a 2+2 program between the two Institutions. The 2+2 program will allow students to complete the Associate of Applied Science in Fire and Emergency Services Associate Degree with concentrations in Emergency Services Technology, Safety and Health Compliance, and Fire Service Technology, and transfer credit hours applied to the Fire and Emergency Services degree as listed in Appendix A to Northwestern State University in partial fulfillment of degree requirements for the Bachelor of Science Degree in Unified Public Safety Administration at NSU. Both universities serve the needs of their constituency and are responsive, student oriented institutions that prepare their students to become productive members of society as well as promote the academic development and improvement in the quality of life of citizens in their regions.

This partnership is mutually beneficial to both institutions for several reasons. Traditional and non-traditional students attending LSUE have said that they want and need an opportunity after completing their fire and emergency services studies from LSUE to transfer to a four-year program that will accept LSUE's fire and emergency services credits.

Both Universities have full-time, tenure track faculty with advanced academic and field experience credentials.

Both institutions have extensive support resources (i.e., library, on-line access, service courses, and adequate administrative – faculty – staff backup).

Northwestern State University has excellent on-line instructional capabilities and the Unified Public Safety Administration Bachelors Degree is available via the Internet.

Northwestern State University offers a partial tuition exemption for students employed full-time as a public safety officer.

In accordance with this Memorandum of Understanding, Louisiana State University Eunice Community College agrees to:

Have LSUE students who plan to transfer to NSU to complete a Bachelor Degree in Unified Public Safety Administration Degree to file intent to transfer form with NSU to establish the catalog of record for their graduation from NSU.

Jointly with Northwestern State University, market the 2+2 Agreement to prospective students.

Provide information about the 2+2 Agreement in the Louisiana State University at Eunice catalog.

Provide students the opportunity to obtain the LSUE credit hours as listed in Appendix A of the Memorandum of Understanding between NSU and LSUE.

In accordance with this Memorandum of Understanding, Northwestern State University agrees to:

Accept Louisiana State University at Eunice credit hours as listed in Appendix A of the Memorandum of Understanding between Northwestern State University and Louisiana State University at Eunice.

Along with Louisiana State University at Eunice, jointly market the 2+2 Agreement.


