 - They do not have an SSN, and it asks for one, not giving them the option no to enter. For address, it is difficult, or not possible, to enter an address located outside of the U.S.
 - It asks for type of visa, but until they are admitted, they do not even have the paperwork to apply for a visa.
 - Under Planned Course of Study, the list of majors, when chosen International Student, only appears a limited list of majors, and they cannot choose the one they are actually applying for.
 - When they need to choose a HS they attended, they only have options of U.S. High Schools. If they do not choose something, they cannot proceed.

• And when the application is submitted and comes through, it often comes with errors, or empty. *Academic Advising Updates:*
