- 2021/22 FY Appropriations As Dr. Maggio advised, while we did not receive all the funding that we need, we did have a successful session. Our funding was increased by \$1 million for faculty pay; \$542,000 for mandated costs which are earmarked for increases in specific items such as ORM, Legislative Auditor costs, Market Rate adjustments for classified, and Group Benefits; \$1.1 million in our formula funding. We are reviewing the formula increase to determine the factors that generated the increase in hopes that these can be focused on for future years.
- 2020/21 Year End close—Thank you for your assistance with submitting all purchasing and travel paperwork so that we can process our year end close timely. If you have any outstanding issues, please contact our office.
- Legislative Auditors- Auditors are on campus and are asking for data to complete the 2019/20 and 20/21 fiscal years audit. • Summary of projects handled by Capital Outlay and Special Projects has be working on the findings of the ADA Audit by LCTCS in November of 2020. All findings have been answered and submission has been approved by LCTCS. Physical Plant has been working on each finding to correct the

violations. Items that are to be done by the University Carpenters have been given to Chris Fulton to correct; his staff has been working on correcting the violations. in his area. (Door pressure adjustments, height of coat hooks on back of stalls in restrooms, height of paper towel dispensers and soap dispensers.) I have the sign violations for inside buildings, way finding signs for accessibility to handicap entrances outside the buildings. New signage has been ordered to correct sign violations all over campus. Dale Wohletz has been given any major corrects that are noted in the Audit. Any construction issues are in the planning stage to correct the issues.

• Capital Outlay Office is also working on the first submission of the 22-23 Capital Outlay Budgets to be forwarded to Bruce Janet the First of July. These will include any item not funded in the previous House Bill 2 for Capital Outlay. This list will be submitted to Jennifer Kelly prior to submission to the ULS Board and The Louisiana Board of Regents.
