I. COLLEGE OF BUSINESS

A. Make the following change to the Computer Information Systems Major requirements:

- Add CIS 3100 to the list of required Support Courses.

Computer Information Systems Major Requirements: (72 semester hours) Students seeking a major in Computer Information Systems must complete 72 semester hours, within the 122 semester hour Computer Information Systems curriculum consisting of a CIS core, composed of: CIS 1030, 2020, 2980, 3400, 3900, 4020, 4100 and 4600, and 12 semester hours of advanced CIS electives. Additionally, the following CIS support courses are required: ACCT 2000 and 2010; BUAD 2120, 3250, 3270; **CIS 3100**; FIN 3090; MGT 3220, 3580, 4300; MKTG 3230 and one advanced Business elective (3 semester credit hours).

- B. Make the following change to CIS 4030 (E-Commerce Systems: Client-Side Development):
- Delete CIS 1030 as a prerequisite.
