#### I. Department of Biological Sciences

#### A. Add the following new concentration:

Forensic and Clinical Laboratory Sciences (618R): Acceptance into an affiliated program and completion of: MEDT 4040, 4050, 4060, 4070, 4080, 4090, 4100; and 9 hours of advisor approved forensic related electives for a concentration total of 39 hours. Enrollment in this concentration does not guarantee acceptance into the training program. All affiliates are approved by the Council on Allied Health Education and Accreditation.

#### B. Make the following change to the Wildlife Management Minor (M91):

 Add GEOG 2010 (Physical Geography) as an alternative to PSSC 2100-2101 (Plant and Soil Science Lecture and Lab).

## D. Add the following statements as notes under the Veterinary Technology (725) curriculum:

- Students entering the Veterinary Technology curriculum are strongly encourage to receive rabies prophylaxis immunization prior to enrolling in VTEC courses, as many laboratories involve working directly with live animals. Students electing not to receive immunization must sign a "Statement of Release."
- Students enrolled in VTEC courses must meet with the Director of Veterinary Technology at first knowledge of pregnancy to discuss specific risks, and complete a "Statement of Release" if she wishes to remain enrolled.

Action: A discrepancy was noted in the hour values for BIOL 3281. Dr. Jack Pace, Acting Department Head for Biological Sciences, confirmed correct values to be (1-0-3). All items approved without opposition.

#### II. Language and Communication/University College

  - Change curriculum footnote #3 to read:
     Electives may be selected from any Computer Science, Electronics
     Engineering Technology, or Industrial Engineering Technology
     courses, or Mathematics 2050. Electives may include a maximum of
     three hours of occupational field experience.
- B. Make the following changes to the Industrial Engineering Technology (145) program:
  - Change the major requirements to read: Industrial Engineering Technology Major Requirements: (68 semester hours) Students seeking a major in Industrial Engineering Technology must complete 68 semester hours, within the 125 semester hour Industrial Engineering Technology curriculum, which include Electronics Engineering Technology 1300-1301, 1311, 1320-1321, 4940; Industrial Engineering Technology 1020, 1400, 1700, 1800, 2020, 2740, 2400, 2790, 3150, 3530, 3550,3570, 4700, 4720, 4730, 4750, 4960; and nine hours of electives from any Industrial Engineering Technology or Electronics Engineering Technology courses.

Heritage Resources Major Requirements: (54 semester hours) Students seeking a major in Heritage Resources must complete an interdisciplinary program of 54 semester hours within the 122 semester hour Heritage Resources curriculum, which includes a 39 hour concentration, and 15 hours of heritage electives. Students must choose an area of concentration from the listing below consisting of 39 hours in one area, and take an additional 15 hours as electives selected from the two disciplines not chosen as the area of concentration. Students may distribute these electives in a manner that meets their interests (i.e. all in one of the other disciplines or in a combination of both disciplines).

Students must also completed SST 1030 Social Sciences Seminar and SST 4020 Capstone course.

  - 1<sup>st</sup> year add SST 1030; delete Health and Personal Fitness (2 hrs); change "Science 1010, 1020" to "Natural Science<sup>1</sup>".

  - 3<sup>rd</sup> year change 1 hour Sociology elective to 3 hours (increasing year total from 30 to 32).

Note: Above changes will change total hours for the degree from 123 to 125.

  - Change the History (261) major requirements to read:

History Major Requirements: (39 semester hours) Students seeking a major in History must complete 39 semester hours within the 124 semester hour History curriculum, which include History 1010, 1020, 2010, 2020, 3990, and 18 semester hours of advanced American and European/non-American history courses, nine of which must be in one field and nine in the other. Students must also complete SST 1030 Social Sciences Seminar and SST4020 Capstone Course.

- Make the following changes to the History (261) curriculum:
  - 1<sup>st</sup> year add SST 1030; reduce Mathematics from 6 to 3 hours.
  - 2<sup>nd</sup> year add 3 hours of Mathematics; delete 3 hours of Humanities.

All students are also required to take SST 1030 Social Sciences Seminar and SST 4020 Capstone course.

2) Dr. Jay Mersch requested that submission deadlines for proposals to the CRC be observed more rigorously in the future. He voiced his concerns over the accommodations afforded for late submissions to this final meeting of the 2006-07 Curriculum Review Council, which resulted in a limited amount of time for Council members to review proposals prior to the meeting.

Dr. Thomas Hanson agreed, stating that his position on the matter was that deadlines were made to be met. He went on to ask if anyone wished to make a proposal to the council concerning the matter.

Dr. Mersch moved to approve Dr. Hanson's statements concerning the enforcement of deadlines.

Dr. Roger Chandler questioned if there should be any exceptions considered.

Mr. John Williams stated that the council could always move to suspend the rules.

Dr. Hanson added that there are always exceptions to any rule. He went on to add that only in crisis situations should last minute changes be allowed. Dr. Mersch suggested that when there was a need for last minute changes that the council receive the bulk of the agenda with the last minute items to follow as soon as possible.

Ms. Lillie F. Bell added that departments waiting until the last meeting of the year to submit the bulk of their proposals hinders the timely completion of catalog revisions and interferes with the desired timeline for receipt of the published catalog.

Dr. Hanson stated that he has continuously encouraged the departments to submit their request through the year and not hold them until the end. He indicated that he would remake that request. He went on to suggest that the deadline for the submissions to the final meeting be moved forward a week to allow more time for preparation for council review. He indicated to Ms. Bell that they would discuss this issue further.

On the motion to uphold deadline dates set for submission of proposals to the Curriculum Review Council and to suspend enforcement of the deadline dates only in "crisis situations" -

#### Action: Approved without opposition.

2) Dr. Bill Dickens questioned whether there had been any discussion in the Graduate Council concerning impending changes in the GRE.

Dr. Roger Chandler responded, informing the council that discussion within the Graduate Council has revolved around the effect on published admission requirements for graduate programs. He indicated that a scale for GRE scores has not yet been made available, making revisions for the Fall 2007 catalog difficult.

Dr. Dickens inserted that the scale would probably not be available under after December, 2007.

Dr. Cathy Seymour added that the only information that has been received concerning the GRE is that the test is going to be harder, be given fewer times, and is to be scored differently. Dr. Seymour went on to add that based on this limited information the Graduate Council felt there was nothing they could do at this time to submit revisions for the next catalog. She also added that every effort is being made by the university to encourage students to take the GRE as soon as possible.

Dr. Chandler also added that the council is anticipating something similar to the recalibration that was done with ACT scoring.

Dr. John Hillebrand questioned if there was any discussion on publishing a statement in the 2007 catalog to the effect that at the time of printing the new scale was unknown.

Dr. Chandler responded that this was discussed but that the council had determined that such a statement might be misleading.
