**I. School of Social Sciences**

A. Add the following new courses for undergraduate credit:

- CJ 3390 – Homeland Security (3-3-0)
- CJ 4590 – Police Leadership and Administration (3-3-0)
- PSCI 4980 – Special Topics (3-3-0)
- SST 4980 – Special Topics (3-3-0)

B. Make the following course changes:

- SOC 4100 – Practicum in Sociology:
  - Change hour values from (6-6-0) to (1 to 6-3-0)
  - Change course description
  - Delete co-requisite
  - Change activity code from lecture to independent study
  - Change terms offered

## II. College of Education

### A. Make the following changes to the Middle School Education, Grades 4 -8 (3103) program:

- Increase total **General Education coursework** from 44 to 59 hours by adding Math 2030, 2040; six hours of Natural Science; History 3040; and change History 2010 to History 2020.
- Change **Methodology in Teaching** requirements by deleting Reading 4080 and adding Reading 3060.
- Change the **Primary and Secondary Teaching Areas** to read:
  - Primary Teaching Area (ENGLISH-18 hours): ENGL 3200, 4640; ENGL 3100, 3150, 3160 or 3170 (6 hours); ENGL 4190; ENGL 4350, 4360, 4570 or 4590 (3 hours); Secondary Teaching Area (SOCIAL STUDIES-9 hours) GEOG 1020; HIST 1020; ECON 2000.
  - Primary Teaching Area (SOCIAL STUDIES-18 hours): GEOG 1020, 3050; HIST 1020, 2010; ECON 2000; PSCI 2020; Secondary Teaching Area (ENGLISH-9 hours): ENGL 3200, 4640; ENGL 3100, 3150, 3160 or 3170 (3 hours).
- Make the following changes to the curriculum:
  - 1<sup>st</sup> year: Add: CHEM 1030, 1070 or SCI 1010 (3 hrs); BIOL 1010-1011 or SCI 1020 (3-4 hrs). Delete: Natural Science<sup>3</sup> (6 hrs). Change total hours for year from 33 to 33-34.
  - 2<sup>nd</sup> year: Add: SCI 2000, 2010, 2020, 2030 or Physics 1120 (6 hrs). Delete: Natural Science<sup>3</sup> (3 hrs). Change total hours for year from 32 to 35.
  - 3<sup>rd</sup> year: Add ENGL 3100, 3150, 3160, or 3170 (3 hrs); MATH 2040; SCI 2000, 2010, 2020, 2030, or PHYS 1120 (3 hrs), Primary or Secondary Teaching Areas courses (6 hrs). Delete: ECON 2000; ENGL 3000/4000 level (6 hrs); GEOG 2020 or 3050; HED 3160; HIST 2020; PSCI 4010. Change total hours for year from 35 to 30.
  - 4<sup>th</sup> year: Add ECON 2000; Primary or Secondary Teaching Area courses (3 hrs). Delete ENGL 3000/4000 level (6 hrs).
  - In curriculum Footnote #2: Change History 2010 to History 2020.
  - Change curriculum Footnote #3 to read: Must be taken concurrently.
  - Change curriculum Footnote #4 to read: Must be taken as a block.
  - Delete curriculum Footnote #5.

### B. Add the following new course for undergraduate credit:

- EDUC 3390 – Cooperative Teaching Experience (1-1-0).

C. Add the following new course for graduate credit:

- EDUC 5390 – Cooperative Teaching Experience (1-1-0).
