Instrumental majors have the option of taking all 9 hours in one language, however, vocal majors must take 3 hours in a different language than their initial 6 hours. All music students must elect one of the concentrations listed below:

Sacred Music Concentration (242M): Music 1710 for four semesters (8 credit hours), MUS 3710 for three semesters (6 credit hours), MUS 1230 (Diction), MUS 2120, 2130, 3120, 3130, 4120 (Church Music History, Liturgics, Hymnody, and Administration), MUED 4520 (Choral Literature), MUS 3100 (Choral Conducting), MUS 4720 (Senior Recital), MUS 1800, 1810, 1820, 1830, 8 hours of ensembles, and 4 hours of Performance Electives in MUS 1700.

B. Change the Vocal Music Education, Grades K – 12 major requirements to read:

Vocal Music Education, Grades K-12 Major Requirements: (97 semester hours) Students seeking a major in Vocal Music Education, Grades K-12 must complete 97 semester hours of the 138-semester hour degree within the Vocal Music Education, Grades K-12 curriculum. 72 hours comprise the basic musicianship component of the degree and 25 hours are from professional education courses. Of the 72 hours in music, 26 hours are for courses unique to the Vocal Music Education curriculum.

C. Change the Instrumental Music Education, Grades K – 12 major requirements to read:

Instrumental Music Education, Grades K-12 Major Requirements: (97 semester hours) Students seeking a major in Instrumental Music Education, Grades K-12 must complete 97 semester hours of the 138semester hour degree within the Instrumental Music Education, Grades K-12 curriculum. 72 hours comprise the basic musicianship component of the degree and 25 hours are from professional education courses. Of the 72 hours in music, 26 hours are for courses unique to the Instrumental Music Education curriculum.

D. Change the Vocal and Instrumental Music Education, Grades K – 12 major requirements to read:

Vocal and Instrumental Music Education, Grades K-12
Major Requirements: (123 semester hours) Students seeking
a major in Vocal and Instrumental Music Education, Grades
K-12 must complete 123 semester hours of the 164-semester
hour degree within the Vocal and Instrumental Music
Education, Grades K-12 curriculum. 98 of these hours
comprise the basic musicianship component of the degree and
25 hours are from professional education courses.

SSCI 480T and SSCI 482T may be counted toward the biology electives if on a biological topic.

Natural Science (838B): Select from BIOL 2000, 2030-2031, 2050-2051, 2080-2081, 2100-2101, 2140-2141, 2150-2151, 2180, 3010-3011, 3040-3041, 3060, 3140-3141, 3220-3221, 3340-3341, 4030, 4040-4041, 4170-4171, 4180-4181, 4200-4201, 4400-4401, or 4960.

Applied Biology (838C): Select from BIOL 2000, 2030-2031, 2040, 2060-2061, 2080-2081, 3010-3011, 3030, 3050, 3060, 3090-3091, 4150, 4160-4161, 4200, 4201, 4210-4211, 4220-4221, 3280, 4300-4301, 4310-4311, 4350-4351, or 4360-4361.

Forensic and Clinical Laboratory Sciences (838R): This concentration requires acceptance into an affiliated training program approved by the Council on Allied Health Education and Accreditation. Enrollment in this concentration does not guarantee acceptance into the training program. You must take BIOL 4730, 4740, 4750, 4760, 4770, 4780 and 4790; and then select 9 semester hours from BIOL 2070-2071, 3500-3501, 4160-4161, 4300-4301; CJ 2600, or 4470.

#### D. Change the Music (813) joint major program requirements to read:

Music (813)<sup>2,3</sup>: specific core requirements - SFRE 1810, 2810, and 2820; or SGER 1810, 2810, and 2820; support courses: SLSC 4000, SFPA 480T, SFPA 482T; vocal students in the Performance concentration and students in the Sacred Music concentration must take at least 3 hours of a second foreign language; 85 semester hours within the Music curriculum. 48 of these hours are specific to the particular concentration while the remaining 37 hours consist of support courses in music. Concentrations: Performance (813A) 1.2.3 - MUS 1710 (12 credit hours), 3710 (12 credit hours), MUS 4150 (Pedagogy), MUS 4390 (Performance Literature). MUS 4720 (Senior Recital), MUS 1800, 1810, 1820, 1830, 8 hours of ensembles, and 4 hours of Performance Electives in MUS 1700. Sacred Music (813B)<sup>2,3</sup> - MUS 1230 (Diction), MUS 2120, 2130, 3120, 3130, 4120 (Church Music History, Liturgies, Hymnody, and Administration). MUED 4520 (Choral Literature), MUS 3100 (Choral Conducting), MUS 4720 (Senior Recital), MUS 1800, 1810, 1820, 1830, 8 hours of ensembles, and 4 hours of Performance Electives in MUS 1700. No grade in music lower than a C may be counted toward the major or as a prerequisite.

Instrumental Music Education, Grades K-12 (827) 1.2 Major Requirements: (97 semester hours) no specific core requirements; support courses: SLSC 4000, SFPA 480T, 482T; Students seeking a major in Instrumental Music Education, Grades K-12 must complete 97 semester hours of the 166-semester hour degree within the Instrumental Music Education, Grades K-12 curriculum. 72 hours comprise the basic musicianship component of the degree and 25 hours are from professional education courses. Of the 72 hours in music, 26 hours are for courses unique to the Instrumental Music Education curriculum.

#### F. Change the Vocal Music Education, Grades K-12 (828) joint major program requirements to read:

Vocal Music Education, Grades K-12 Joint Major Requirements (828) 1,2; (97 semester hours)

no specific core requirements; support courses: SLSC 4000, SFPA 480T, 482T; Students seeking a major in Vocal Music Education, Grades K-12 must complete 97 semester hours of the 166-semester hour degree within the Vocal Music Education, Grades K-12 curriculum. 72 hours comprise the basic musicianship component of the degree and 25 hours are from professional education courses. Of the 72 hours in music, 26 hours are for courses unique to the Vocal Music Education curriculum.

Action: Item C: Dr. Helaine Razovsky, on behalf of the Louisiana Scholars' College, requested the concentration-dependent courses be amended as indicated in red above. Items E and F: It was noted that the School of Creative and Performing Arts had presented the program changes to the Teacher Education Council (TEC) at its February meeting and that the proposals had met with approval. However, the Louisiana Scholars' College joint major programs were not presented for

consideration. Dr. Hanson proposed that the CRC decision be contingent on later TEC review and approval. All items approved without opposition.

# IX. Electronic and Continuing Education

A. Replace the text under the heading "Credits through Prior Learning Assessment" (current catalog, pg. 32) with the following:

Students may petition for the acceptance of credits for learning experiences that occurred after high school but prior to admission to the university. A student's past postsecondary education and experiences are assessed through a formal process called Prior Learning Assessment (PLA). This process is in accordance with commonly accepted good practice in higher education and satisfies criteria established by the Southern Association of Colleges and Schools (SACS) Commission on Colleges and the Council for Adult and Experiential Learning (CAEL).

A student petitioning for PLA credits must complete a course in foundations of professional studies, develop a PLA plan with an advisor, and submit portfolios that document the experiential learning to be assessed by subject matter faculty through the formal process. This process is handled through the office of Electronic & Continuing Education by the Coordinator of Adult Education Initiatives.

The policy for assessed credit will be governed by the Prior Learning Assessment Council. #### X. <u>University College</u>

A. Replace the text under the subheading "Prior Learning Credits in the Professional Studies Concentration" (current catalog, pg. 118) with the following:

Students in the Professional Studies concentration in the Bachelor of General Studies (BGS) must meet the established criteria for "adult learner" (i.e., have at least 60 semester credit hours or completed high school 3 or more years ago). In addition, these students must be eligible for at least 6 semester credit hours of prior work experience. A maximum of 30 hours credit from past occupational, educational and training experiences may be applied toward the Professional Studies concentration in General Studies, Students enrolled in the Professional Studies concentration may petition for the acceptance of Prior Learning Assessment (PLA) credit to be used to complete degree requirements. Credit for these learning experiences will be established by departmental evaluation using appropriate guidelines from Southern Association of Colleges and Schools and Council for Adult and Experiential Learning. General Studies students interested in developing a Prior Learning Assessment Portfolio should contact the University College.

Additionally, the following CIS support courses are required: ACCT 2000 and 2010; BUAD 2120, 3250, 3270; CIS 3100; FIN 3090; MGT 3220, 3580, 4300; MKTG 3230; and one advanced Business elective (3 SCH).

- Add CIS 3980 as an option in the minor requirement.
- Make the following <u>curriculum changes</u>:
  - 3<sup>rd</sup> year: Reduce CIS advanced electives to 3 hours and add footnote reference <sup>4</sup>: Add CIS 3000.
  - 4th year: Reduce CIS advanced electives to 3 hours and add footnote reference 5; Add CIS 4000.

  - Add footnote 5: selected from CIS 4030, 4200, 4300, or 4700.

(2) A course title discrepancy on the Course Change Request Form for CIS 4020 was noted. It was clarified that this was an error and did not constitute a title change request. All items approved with noted corrections and revisions.

Note: February 20, 2008, Ms. Barbara Russell, on behalf of the College of Business, requested that the council consider a revised catalog description for CIS 1800. The revised description offered a punctuation change to the proposed description verses the tense change approved by the council. Action: An email vote was conducted. The revised description was approved with a majority vote of the council.

Core requirements for the Ed.S. include 15-hours of graduate credit as follows: Research (6-hours), Statistics (3-hours), and Thesis or Field Study (6-hours).

#### B. Educational Technology Concentration (582H)

Core: Research (6-hours), Statistics (3-hours), and Thesis or Field Study (6-hours) Educational Technology Concentration: Educational Technology and related courses (24-hours)

#### C. Educational Leadership concentration (582I)

Core: Research (6-hours), Statistics (3-hours), and Thesis or Field Study (6-hours) Educational Leadership Concentration: Educational Leadership and related courses (24-hours)
