I. School of Creative and Performing Arts

- A. ART 2340 (Painting II): Change prerequisite.

Action: Approved without opposition.

II. Criminal Justice Department

- A. Make the following changes to the Unified Public Safety Administration concentration areas to correct course number and course title errors/omissions:
- **Law Enforcement Administration (256A)** - Add: "Law and Public Policy" after "UPSA 4400"; Add: "Management" after "UPSA 3400 Crisis Intervention"; Change "UPSA 2900" to "UPSA 3900."

- **Fire and Emergency Medical Services Administration (256B)** - Change “2260” to “2250”; Add: “Management” after “UPSA 3400 Crisis Intervention”; Change “UPSA 2900” to “UPSA 3900.”
- **Emergency Management Administration (C)** - Add: “Management” after “UPSA 3400 Crisis Intervention”; Add “Methods” after “Hazards Risk Assessment”; Change “UPSA 2900” to “UPSA 3900.”

Action: Approved without opposition

III. Louisiana Scholars’ College

- A. Add SSTA 3810 as an option to PSYC 4400 in the Psychology joint major program requirements.
- B. Make the following course changes:
- SSCI 2010 – add the wording “and corequisites” to the course description.
 - SSCI 2020 – change requirements to select “two” from the options listed.
 - SSCI 2030 – change requirements to select “three” from the options listed.

Action: Approved without opposition

IV. Department of Language and Communication

- A. Add the following footnote to ENGL 0920, 1010, 1020, 2050, 2060, 2070, and 2080:
- ²Students must earn a C or better in ENGL 0920, 1010, 1020, and the sophomore literature courses in order to be able to enroll in 3000 and 4000 level ENGL courses.
- B. Add the following concentration area to the English (221) curriculum:
- **Folklife-Southern Culture (221C):** ENGL 2050 and 2060 or 2070 and 2080. ENGL 4670, 4650 and eighteen hours in literature of the American South and Folklore. Nine additional hours at the upper level may be taken in linguistics, writing, American literature, or British literature. (39 upper level hours in English must be completed)
- C. Add the following new courses for undergraduate credit:
- ENGL 3000 – The Origins of Children’s Literature (3-3-0).
 - ENGL 3010 – Teaching Young Adult Literature (3-3-0).
 - ENGL 4870 – Folklore and Film (3-3-0).

- COMM 4280 – Communication and Power (3-3-0).

Action: Item "B" amended to add the designation of "nine" additional hours at the upper level, as indicated above. All items approved without opposition.
