I. COLLEGE OF SCIENCE, TECHNOLOGY, AND BUSINESS

A. Make the following changes to the natural science component of the University core:

- Add BIOL 1020 and BIOL 1021 as an option for the associate (non-designated) degree programs.
- Delete BIOL 2220-2221, 2230-2231 for all degree programs.
- Add BIOL 2250-2251, 2260-2261 for all degree programs.

Action: Item initially tabled due to no representative being present. Following Dr. Steve Horton's outline of the proposal via telephone conference the council reconsidered the proposal. Item passed with a majority vote.

II. DEPARTMENT OF LANGUAGE AND COMMUNICATION

A. Add the following new course for undergraduate credit:

- ENGL 3530 – Video Production (3-3-0).

Action: Dr. Sarah McFarland requested the council consider the department's additional item on the agenda addendum (Item IX) at this time. Council approved her request. Both items approved without opposition.

- Biology Education (825B): Delete SMAT 1840 and add SMAT 2000 in the General Education specific requirements.
 - English Education (825A): Delete SMAT 1840 from the SMAT options.
 - Social Studies Education (825D): Delete SMAT 1840 from the SMAT options.
- T. Make the following change to the joint major in Theatre (814):
- 1st year: Delete SMAT 1840 from the SMAT options.
 - 4th year: Delete SMAT 1840 from the SMAT options.


U. Make the following change to the joint major in Unified Public Safety Administration (856):

- 1st year: Delete SMAT 1840 from the SMAT options.
- 2nd year: Delete SMAT 1840 from the SMAT options.

Action: Dr. Bill Dickens informed the council the Health and Human Performance Department had not been made aware of the proposed change to the joint major. He questioned if any departments had been contacted to review the changes. Dr. Curt Phifer, for the Louisiana Scholars' College, responded they had not. Dr. Kimberly McAlister indicated the need for discussion with the academic departments to avoid potential conflicts. Dr. Phifer agreed and upon suggestion of the council, agreed to send the proposed changes to department heads for review. Items X-D through X-U approved without opposition pending review by the respective academic departments. All additional items approved without opposition.
