I. Department of Biological and Physical Sciences

A. Add the following new course for undergraduate credit:

• BIOL 4280 – Pathophysiology (3-3-0).

II. Louisiana Scholars' College

- A. Revise the minor in Philosophy to read:
 - Philosophy Minor Requirements: PHIL 1010, 2030 or SPHI 3850; two courses from SPHI 3710, 3740, 3810, or 3840; and five additional hours of philosophy with the PHIL or SPHI prefix. (19 hours).
- B. Make the following changes to the **Computer Information Systems Joint major** (802):
 - Change major requirements to read:
 - Computer Information Systems Joint Major Requirements: (76 semester hours) Students seeking a major in Computer Information Systems must complete 76 semester hours, which include:
 - 18 semester hours in the Computer Information Systems core (CIS 1015, 1030, 2050, 2980, 3900, 3980)
 - 18 semester hours in a Computer Information Systems concentration.
 - 24 semester hours of School of Business requirements: ACCT 2000 and 2010; BUAD
 - 3270 and 3280; FIN 3090; MGT 3220 and 3580; MKTG 3230
 - 16 semester hours of Scholars' College requirements: SMAT 1820 or 2000; SECO 2810, SSTA 3810, SBUS 4000, 480T, and 482T.

- C. Add the following available concentrations:
 - Application Development (802A): CIS 3020, 3300, 4000, 4020, 4100, and 4600.
 - Networking & Systems Management (802C): CIS 3020, 3300, 3400, 4080, 4220, and
- D. Make the following changes to the curriculum:
 - 1st year Delete: SMAT 1820 and 2000 or SMAT 2810; CIS 2020, 2100. Add: CIS 1015; SBIO/SECL/SCHM/PHYS²; SMAT 1820 or 2000.

- 2nd year Delete: SBIO/SECL/SCHM/PHYS²; ACCT 2000, 2010. Add: SSTA 3810; CIS 2050, 3020, 3300.
 3rd year Delete: CIS 3000, 3020, 3300, 3400; SSCI 2030; SSTA 3810.
- Add: CIS concentration (9 hours); ACCT 2000, 2010.

 4th year Delete: CIS 3900, 4000, 4020, 4600.

Add: SSCI 2030; CIS concentration (9 hours).
