I. College of Education and Human Development

A. Add the following new courses for graduate credit:

- EDAL 5100 – Literacy and Adult Learning (3-3-0).
- EDAL 5110 – Learning and Leading in Groups and Organizations (3-3-0).
- EDAL 5120 – Adult Development in Organizational Systems (3-3-0).
- EDAL 5130 – Management of Adult Learning Environments and Organizations (3-3-0).
- EDAL 5510 – Special Topics in Adult Learning (3-3-0).

B. Make the following course changes:

- SAHE 5930 – change course title and course description.

C. Make the following changes to the Continuing Education (510A) concentration:

- Change the title to Adult and Workforce Development (545A).

- Change requirements to reflect a program course change from Adult Education (EAE) courses to the new Adult Learning and Development (EDAL) courses as follows:
 - Foundations: EDAL 5000, 5010, 5020, 5030.
 - Concentration Area: EDAL 5100, 5110, 5120, 5130.
 - Support Area: EDAL 5500.
 - Application Area: EDAL 6000, 6010.

II. Department of Criminal Justice, History, and Social Sciences

- A. Add the following statement to the Pre-law and Paralegal Studies (250B) concentration:
- *Students must have sophomore status before adding and beginning the requirements for this concentration.*
- B. Add the following new minor:
- Pre-law and Paralegal Studies Minor Requirements: (21 semester hours) to include 15 semester hours from PLPS 3020, 3030, 3040, 3050, and 3070, and (6) six semester hours of PLPS electives selected from PLPS 3010, 3060, and 3080. Students must have sophomore status prior to adding and commencing the requirements for this minor. (Two (2) courses are offered each semester).
- C. Make the following changes to the Criminal Justice (250) curriculum:
- 1st year – Delete: Electives³ (3 hours).
Add: CJ 2300 (3 hours).
 - 2nd year – Delete: CJ 2300 (3 hours).
Add: Electives³ (3 hours).

IV. College of Nursing and Allied Health


A. Make the following course change:

- NURG 5075 – Introduction to Integrative Medicine for Health Professionals (3-3-0).


