I. <u>DEPARTMENT OF ENGINEERING TECHNOLOGY</u>

- A. Add the following new course for undergraduate credit:
 - IET 4900 Research Methods (3-3-0).
- B. Make the following <u>changes to the Industrial Engineering Technology (145) and the Industrial Engineering Technology Joint Major (844) curriculums:</u>
 - <u>Major Requirements</u>: Add IET 4900; delete 3 hours of electives from Industrial Engineering Technology or Electronics Engineering Technology courses.
 - 4th year: Add IET 4900; delete 3 hours of Electives.

ACTION: All items approved without opposition.

II. DEPARTMENT OF MATHEMATICS

- A. Add the following new course for undergraduate credit:
 - MATH 4940 Introduction to Mathematical Research (2-2-0).

- B. Make the following course changes:
 - MATH 1010 change grade type from pass/fail to regular grading.
 - MATH 4950 change prerequisite and hour values.
- C. Make the following changes to the Mathematics (642) curriculum:
 - <u>Major Requirements</u>: Add MATH 4940; reduce semester hours from 3000-4000 level mathematics courses from 18 to 15.
 - 1st year: Add Electives⁴ (3 hours); delete CSCI 1060 (3 hours).
 - 2nd year: Add CSCI 1060 (3 hours); reduce Electives⁴ from 6 to 3 hours.
 - 4th year: Add MATH 4940 (2 hours); delete 2 hours of Electives².

ACTION: Approved without opposition.

III. SCHOOL OF ALLIED HEALTH

- A. Make the following course changes:
 - RADS 2210 change hour value from 2 to 3 hours.
 - RADS 4620 change hour value from 2 to 3 hours.
- B. Make the following changes to the Radiologic Sciences (615) curriculum:
 - <u>Major Requirements</u>: Add ALHE 4610; Delete RADS 4610; change total semester hours required from 70 to 73 based on credit hour value changes to RADS 2210, 3311, and 4620.
 - 1st year: Delete HED 1010 (2 hours).
 - 2nd year: Change total hours for RADS courses from 15 to 16 based on credit hour value change to RADS 2210.
 - 4th year: Add ALHE 4610; Delete RADS 4610; change total hours for RADS courses from 22 to 20 based on credit hour value change to RADS 4620 and deletion of RADS 4610.

- A. Make the following course changes:
 - CHEM 1031 Delete CHEM 1030 as a prerequisite; Add CHEM 1030 as a corequisite.
