I. SCHOOL OF NURSING

A. Make the following **changes to the Nursing (546) degree program:**

- Delete the following concentration areas:
 - Adult Gerontology Nursing (546K)
 - Maternal Child and Family Nursing (546D)

- Add the following new concentration areas:
 - Adult Gerontology Nursing Administration (546T)
 - Adult Gerontology Nursing Education (546U)
 - Maternal Child and Family Nursing Administration (546V)
 - Maternal Child and Family Nursing Education (546W)

Action: Approved with the unanimous vote of the council. No opposition.

II. SCHOOL OF EDUCATION

A. Add the following **new concentration to the Secondary Education and Teaching (320) degree program:**

- Agriculture Education (320A): General Education Specific Requirements: MATH 1020, 1090; BIOL 1010, 1020. AGMT 2000; BUAD 1040; CULA 2010; AGMT 3000; EET 1300, 1301, 1320, 1321; BIOL 2040, 1011, 1021, 2030, 2031, 3900.

Action: Approved with the unanimous vote of the council. No opposition.

III. DEPARTMENT OF HEALTH AND HUMAN PERFORMANCE

A. Make the following **course changes:**

IV. DEPARTMENT OF THEATRE AND DANCE

- Delete the 3-hour academic elective, reducing total major hours from 80 to 77 semester hours, and correct semester hours of electives as noted:

- **Production and Design Major Requirements**: (~~80~~ 77 semester hours) Students seeking a major in Production and Design must complete ~~80~~ 77 semester hours, within the 120 semester hour Production and Design curriculum, which include a 48 semester hour production and design core, ~~15~~ 14 semester hour production and design electives and ~~14~~ 15 semester hour theatre and dance electives ~~and 3 credit hour academic elective~~. A “C” or better average is required for all production and design classes to complete requirements for graduation. Foreign language and minor area of study are not required for this degree.

- Production and Design Electives: Delete: THEA 4450 as an option.

Add: THEA 4550 as an option.

SSCI 3010 will not satisfy any requirements for the Scientific Inquiry (820A) concentration.

H. Make the following **change to the Psychology Joint Major (859):**

Add: SCHM 1840, 1841 or SPHY 1830, 1831

I. Make the following **changes to the Secondary Education and Teaching Joint Major (825):**

 - Computer Information Systems Major Requirements: (80 semester hours) Students seeking a major in Computer Information Systems must complete 80 semester hours, within the 120 semester hour Computer Information Systems curriculum consisting of a CIS core, composed of: CIS 1015, 1030, 2980, 3020, 3900, and 4600 and one of the four available 27 hour concentrations described below. Additionally, the following CIS support courses are required: ACCT 2000 and 2010; BUAD 2120, 2200, 3270, 3280, 4900; CIS 1090; FIN 3090; MGT 3220, 3580; and MKTG3230.
- Delete Web Development (102E) concentration.
- Add the following new concentration:
 - Information Systems Management (102H): (27 semester hours) CIS 4840, 4850, 4930; FIN 4220; 1 class from CIS 3300, 4000, 4910; 1 class from CIS 4020, 4070, 4900; 1 class from BUAD3120, CIS 3970, MGT 4500; and 2 CIS electives (6 semester hours) from any CIS class, except CIS 1010, 1060, 2000, 3050, 3100, and 4050.
- Revise following concentrations to read:
 - Application Development (102A): (27 semester hours) CIS 3300, 3970, 4000, 4020, either CIS 2040 or CIS 4060, and 4 CIS electives (12 semester hours) from any CIS class, except CIS 1010, 1060, 2000, 3050, 3100, and 4050.
 - Cyber Security (102G): (27 semester hours) CIS 2080, 2090, 3400, 3410, 3700, 3800, 3980, 4040 and 1 CIS elective (3 semester hours) from any CIS class, except CIS 1010, 1060, 2000, 3050, 3100, and 4050.
 - Networking & Systems Management (102D): (27 semester hours) CIS 2080, 2090, 3400, 3700, 3800, 3980, 4080, 4220 and 1 CIS elective (3 semester hours) from any CIS class, except CIS 1010, 1060, 2000, 3050, 3100, and 4050.
- Curriculum:
 - 1st year – Delete: BUAD 1800, CIS 2000, CIS 2050.
Add: CIS 1090, Natural Sciences¹ (3 hours); CIS concentration (3 hours).
 - 2nd year – Delete: Natural Sciences¹ (3 hours).
Add: CIS concentration (3 hours).

D. Make the following **change to the Business Administration Minor (MI14)**:

- Add BUAD 2200, increasing total hours for the minor from 21 to 24.
